# **Application for Secondary One Discretionary Places**

(2024-25 Academic Year)

# 1. Points for Attention

- 1.1 According to the EDB Regulation, Each Primary 6 student should not submit applications to more than two secondary schools listed in Discretionary Place Stage.
- 1.2 Our school is a "Through-train" Secondary school in the school year 2024-2025. According to the EDB principle, some Secondary One places are reserved for Primary Six pupils to be admitted through the discretionary places or central allocation process.
- 1.3 Submission period for application:

Dates: 2<sup>nd</sup> January, 2024 to 16<sup>th</sup> January, 2024

Office Hours: Monday to Friday: 8:30 a.m. – 5:30 p.m.

Saturday: 9:00 a.m. – 12:00 n.n.

The school is closed on Sundays and all public holidays.

1.5 The number of discretionary places for our school in the school year 2024-2025 is 40.

### 2. Eligibility requirements

- 2.1 Applicants must be eligible for the S1 discretionary places in the school year 2022/24.
- 2.2 Applicants' parents have a shared belief of the school's vision and mission.
- 2.3 Applicants should get Grade B or above in conduct in the previous two years.

## 4. Selection Criteria and Arrangements

- 4.1 The school will refer to the following items when assessing an applicant's performance:
  - a. Applicant's academic performance (35%)
  - b. Applicant's conduct, experience of school service or community social service, extra-curricular activities and special talents (30%)
  - c. Applicant's performance in the interview (35%)
- 4.2 The school will shortlist applicants according to their performance in 4.1a and 4.1b; an interview invitation letter will be sent on or before 1<sup>st</sup> March, 2024. The interview will be held on 9<sup>th</sup> March, 2024. Applicants who do not receive an interview invitation may consider the application unsuccessful.
- 4.3 The school will notify parents of the successful applications of their children's inclusion in the Successful Lists for Discretionary Places by letter and phone on 27<sup>th</sup> March, 2024. Parents may check the results via SSPA e-platform if they have registered before. Parents should not enquire about the allocation results before the published results release date.
- 4.4 According to the EDB, the Final Place Allocation results will be announced together with the central allocation results on 9<sup>th</sup> July, 2024.

#### 5. Others

- 5.1 For special situations such as inclement weather, any changes to application or special arrangements for interview will be announced through our school website (https://www.qts.edu.hk).
- 5.2 Access to students' personal information is restricted by the Personal Data (Privacy) Ordinance. The information collected in the Application Form will be used for the application for S1 places in this school and will be submitted to the School Places Allocation Section of the Education Bureau.
